Which have agreed as follows:

Article 1/Subject

1.1. The Coordinator and the Co-beneficiary commit themselves to carrying out the work programme covered by this contract, for the project entitled "Qualified teachers for a better future for our students", and the course entitled "PBL and GBL methods as a support for future education" under the ERASMUS+ Programme, KEY ACTION KA122-SCH - Short-term projects for mobility of learners and staff in school education.

1.2. This contract regulate relations between the partners, and their respective rights and obligations with regard to their participation in the project under the Agreement number 2022-1-PL01-KA122-SCH-000069109

Article 2/Duration

- 2.1. This contract enters into force on the date of signature by the last of participating parties to the contract and terminates at the moment of payment of the balance of the contract, as mentioned in the article 6, paragraph 1.
- 2.2. The period of implementation of the course is starting on 26/06/2023 and finishes on 03/07/2023.

Article 3/Obligations of the Coordinator

The Coordinator is obliged:

- 3.1. To take all the steps necessary to prepare for, perform and correctly manage the work programme set out in this contract and in its annexes, in accordance with the objectives of the project.
- 3.2. To send to the Co-beneficiary a copy of the Agreement number 2022-1-PL01-KA122-SCH-000069109 and its annexes concluded with Fundacja Rozwoju Systemu Edukacji, of the Financial and Contractual Rules, of the various reports and of any other official documents concerning the project;
- To notify and provide the Co-beneficiary with any amendment made to the Agreement number 2022-1-PL01-KA122-SCH-000069109 concluded with the Fundacja Rozwoju Systemu Edukacji;
- 3.4. To define in conjunction with the Co-beneficiary the role and rights and obligations of the two parties, including those concerning the attribution of the intellectual property rights;

Article 4/Obligations of the Co-beneficiary

The Co-beneficiary is obliged:

- 4.1. To take all the steps necessary to prepare for, perform and correctly manage the work programme set out in this contract, in accordance with the objectives of the project as set out in the Agreement number 2022-1-PL01-KA122-SCH-000069109
- To give the support for participant on each stage of the programme;
- 4.3. To prepare accommodation, travel and programme of the stay for the participants;
- To communicate to the Coordinator any information or document required by the latter that is necessary for the management of the project;



- To accept responsibility for all information communicated to the Coordinator, including details of costs claimed and, where appropriate, ineligible expenses;
- 4.6. To define in conjunction with the Coordinator the role and rights and obligations of the two parties, including those concerning the attribution of the intellectual property rights.

Article 5/Financing

The maximum grant of the Co-beneficiary for the period covered by this contract is estimated at 6 400,00 EUR. Payment for course for 9 participants and 8 days for each participant (8*80 *10 = 6400 EUR)

Article 6/Payment Arrangements

6.1. The Coordinator commits himself to carrying out payments relating to the subject matter of this contract to the Co-beneficiary according to the achievement of the tasks and according to the following schedule:

A total payment will be made after the completion of the course 6400,00 EUR, within 30 days after the completion of the course.

Article 8/ Monitoring and supervision

- 9.1. The Co-beneficiary shall provide without delay the Coordinator with any information that the latter may request from him concerning the carrying out of the work programme covered by this contract.

- 9.3. The obligations described in Article II.27 of the Agreement number 2022-1-PL01-KA122-SCH-000069109 apply to the Coordinator and the Co-beneficiary.

Article 9/ Liability

10.1. Each contracting party shall release the other from any civil liability in respect of damages resulting from the performance of this Agreement, suffered by itself or by its personnel, to the extent that these damages are not due to the serious or intentional negligence of the other party or its personnel.

Article 10/Termination of the contract

- 11.1. The Coordinator may terminate the contract if the Co-beneficiary has inadequately discharged or failed to discharge any of the contractual obligations, insofar as this is not due to force majeure, after notification of the Co-beneficiary by registered letter has remained without effect for one month.
- 11.2. The Co-beneficiary shall immediately notify the Coordinator, supplying all relevant information, of any event likely to prejudice the performance of this contract.

Article 11/ Jurisdiction clause

- 12.1. Failing amicable settlement, the Courts of the Hellenic Republic shall have sole competence to rule on any dispute between the contracting parties in respect of this contract.
- 12.2. The law applicable to this contract shall be the law of the Hellenic Republic.

Article 12/ Amendments or additions to the contract

Amendments to this contract shall be made only by a supplementary Agreement signed on behalf
